Nick has been instructed in catastrophic injury claims arising out of the Animals Act, assaults, construction sites, electrocution, employer's liability, factories, farming, fairgrounds, forestry, groundwork, highways (maintenance and design) mining, occupier's liability, product liability, quarries, road traffic (agricultural machinery, cyclists, motor cyclists, pedestrians and vehicles), steelworks, prisons, shipping, theme parks, workplace, work equipment, working at height.

Fatal Accident Act claims and appeals against the Criminal Injuries Compensation Authority also form an important part of his work.

Nick is recommended as a Band 1 junior by Chambers and Partners and a Tier 1 junior by the Legal 500 for personal injury.
